## Declaration by Account Holder/Applicant

- Account Holder**  
I/We confirm and agree (and where the Account Holder is a company or a trust, we are authorised on behalf of the company or in terms of the trust deed to confirm and agree) that PGG Wrightson Limited ("PGG Wrightson") and American Express International (NZ), Inc. ("American Express") (together referred to as the "Card Operators") are requested and authorised to issue the Card to both of the Applicants named in this application form.
- Account holder and both applicants**
  - I/We acknowledge that the Terms and Conditions which govern the operation of the Card and which will accompany the Card when it is issued apply to the Account Holder and both Applicants and I/we agree that this application is made subject to those Terms and Conditions and I/we agree to comply with all of those Terms and Conditions which apply to me/us.
  - I/We confirm and agree that PGG Wrightson is authorised to direct debit all Charges incurred in respect of each Card issued to the Applicants ("Cards") to the PGG Wrightson Account referred to above. Where the Account is with PGG Wrightson Finance Limited, PGG Wrightson Finance Limited is authorised to debit the Account and to reimburse PGG Wrightson for the amount so debited.
  - Notwithstanding that the PGG Wrightson Account may be in the name of some other person, company or entity, Basic and Additional Cardmembers are jointly and severally liable with the Account Holder for all Charges incurred on that Cardmember's Card.
  - I/We request the Card Operators to issue a Card to each Applicant, and renew and replace that Card until the Account Holder, an Applicant or the Card Operators cancel that Card. I/We acknowledge and agree that, if this application is accepted, the PGG Wrightson Account will be debited with an annual Card fee of \$45 for the Basic Card and \$30 for the Additional Card. I/We further understand and agree that these fees are subject to change without notice. I/We understand that a copy of the Terms and Conditions is available to the Account Holder and the Applicants on request and will accompany the Card issued to each Applicant if this application is accepted. I/We understand that the Card Operators are under no obligation to accept either of the applications made in this form and may refuse any application without giving reasons.
  - I/We permit the Card Operators to receive and exchange confidentially any information about me/us that they may require for the purpose of issuing and operating the Cards including, without limitation, information relating to the PGG Wrightson Account, any previous or subsequent account or card dealings in relation to the Cards or any other dealings that I/we may have had or may have (including in relation to any other card) with either Card Operator or its related companies. I/We understand that such information may be transferred confidentially to other companies in the American Express and PGG Wrightson group of companies and may be disclosed by either Card Operator to the Account Holder or to either Applicant.

- I/We also permit and authorise the Card Operators to request at any time information about me/us from credit reporting agencies, financial institutions, credit providers and any of our employers (to confirm employment and salary details) and from the Account Holder and either Applicant to the Card Operators. I/We agree that the Card Operators may disclose information arising out of the operation or use of either card to credit reporting agencies, financial institutions and credit providers.
- I/We agree that the Card Operators may use any such information for business purposes that include, but are not limited to, either Applicant's application for a Card, the approval process as it relates to purchases with the Card, the administration of any Card account, any PGG Wrightson Account or any transaction the Account Holder and/or either Applicant may have with either the Card Operator (or both of them) or with any other company in the American Express or PGG Wrightson group of companies, and for marketing purposes.
- I/We understand that I/we have the right to request access to, and correction of, the information held about me/us in accordance with the Privacy Act 1993. This information will be held at the PGG Wrightson Head Office and at the offices of American Express.
- I/We agree that the Card Operators (or either of them) may produce the original or a copy of other reproduction of this application as evidence of the Applications for (and the Account Holder's request and authorisation of the issue of) the Cards. I/We certify that all of the information given by me/us in this application form is true and correct.

### FOREIGN CURRENCY CHARGES

If you make a Charge in a currency other than New Zealand dollars, that Charge will be converted into New Zealand dollars. The conversion will take place on the date the Charge is processed by American Express, which may not be the same date on which you made your Charge as it depends on when the Charge was submitted to American Express. If the Charge is not in U.S. dollars, the conversion will be made through U.S. dollars, by converting the Charge amount into U.S. dollars and then by converting the U.S. dollar amount into New Zealand dollars. If the Charge is in U.S. dollars, it will be converted directly into New Zealand dollars. Unless a specific rate is required by applicable law, you understand and agree that the American Express treasury system will use conversion rates based on interbank rates that it selects from customary industry sources on the business day prior to the processing date, increased by a single conversion commission of 2%. If Charges are converted by third parties prior to being submitted to us, any conversions made by those third parties will be at rates selected by them. For your information, the conversion commission remains unchanged.
